- Zhangjiayao Forest Management Company Ltd., Kangping County, Liaoning Province, P.R.China is permitted to transfer to Keio University which is authorized by the Government of Japan no more than 30,000 t CO<sub>2</sub>e in total Certified Emission Reductions (CERs).
